**Identity and Statement of Educational Purpose**

Your FAFSA was selected by the US Department of Education to verify your Identity and Statement of Educational Purpose. This process requires that our office collect proof of your identity and that you sign and submit documents to Blugold Central (upload, fax or email copies will not be accepted). There are **two options** to complete this process.

1. The student must appear in person at UW-Eau Claire, to verify his or her identity by presenting:
  - a. An unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver’s license, other state-issued ID, or passport. The institution will maintain a copy of the student’s photo ID that is annotated by the institution with the date it was received and reviewed and the name of the official at the institution authorized to receive and review the student’s ID.
  - b. In addition, the student must sign, in the presence of the institution official, the Statement of Educational Purpose below.
2. If the student is unable to appear in person at UW-Eau Claire to verify his or her identity, the student must provide the institution:
  - a. A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a driver’s license, other state-issued ID, or passport; **AND**
  - b. The original Statement of Education Purpose is provided below, which must be notarized.
