- 2014 SF 511 (5-14-2014) creates a separate license for advanced practice registered nurses (APRN) and permits licensed advanced practice nurses to practice independently without a collaborative agreement. (Senate Health and Human Services Committee Lobbying)
- 2005 H1385A23 (5-12-2005) Higher Education Bill "the state universities shall offer undergraduate and graduate instruction through the master's degree, including specialist certificates, in the liberal arts and sciences and professional education, and may offerapplied doctoral degrees in the areas of education, psychology, physical therapy, audiology, and nursing" (House Higher Education Committee Testimony)

Other Activities that Demonstrate Sustained Contributions

1995 – Present Led initiatives in family-focused nursing

- In 1995, I was a founding member of the Family Nursing Research Team (FNRT) at Minnesota State University, Mankato and continue to work with this team. We have conducted four major studies over that time with foundation and university funding. We have published 5 articles and 3 book chapters based on these studies.
- In 2005, the FNRT presented the Douglas R. Moore lectureship "Challenges of chronic illness: Artistic interpretation of the family re-integration process" at MSU, M, bringing notoriety about family nursing to the university.
- In 2008, the Glen and Becky Taylor Institute for Family and Society Nursing was launchedat Minnesota State University, Mankato and I was the original co-chair of the Institute in 2008-2009.
- In 2009, under my leadership along with my co-chair, Dr. Sandra Eggenberger, the Glen and Becky Taylor Institute provided substantial funding to launch the International Family Nursing Association (IFNA), an organization that now has over 460 international members with international influence.
- In 2020, I am the first author of an article accepted for publication, *Measuring family members' experiences of integration of chronic illness into family life: Preliminary validity and reliability of the Family Integration Experience Scale-Chronic Illness (FIES.CI)* doi:10.1177/1074840720902129

Caring Conversation Guide in Chronic Illness, using the FIES.CI.

• I am leading development of an interprofessional mixed methods research study "Support of Children and Kinship Caregivers (SPOCK)" to examine the needs of children and kinship caregivers in the context of substance use disorder.

2009 – Present Led initiatives to facilitate excellence in APRN Nurse Anesthesia Education

• I provided leadership to the Mayo Clinic Nurse Anesthesia program as a professor teaching courses and as a community member of their curriculum advisory committee. I consulted with Dr. Mary Marienau and her faculty team in transitioning the program from master's to doctoral level curriculum. Lessons learned about the process of conducting distance-mediated international family nursing research were also shared at this conference.
- In 2017, I led the International Research Subcommittee's launch of the Acute Care Family Nursing Research Cluster. This cluster presented their multi-site, international research protocol at International Family Nursing Conference (IFNC14) in Washington, D.C. and they are currently conducting data analyses of interviews with nurses in acute care settings across the globe. Currently, the Acute Care Family Nursing Research Cluster and the Defining Family Nursing Cluster are developing a manuscript about cross-cultural research.
- In 2019, I mentored the new Subcommittee Chair in launching the Pediatric Family Nursing Research Cluster, based on successful strategies learned in original Subcommittee work.
